Memorandum of Understanding

This Memorandum of Understanding (MOU) by and between **Center for Human Services**, hereinafter referred to as **CHS**, and **Patterson Joint Unified School District**, hereinafter referred to as **PSD**, in consideration of the premises and the mutual promises, covenants, terms and conditions hereinafter contained.

Whereas, **CHS** delivers counseling and support group services to our local city schools and community residents and;

Whereas **PSD** has students with identified needs for individual evaluation/screening and individual, family, group counseling, case management and;

Whereas **CHS** and **PSD** wish to collaboratively facilitate the educational success of students enrolled at **PSD** sites.

Now, therefore, the parties agree to the following:

PATTERSON JOINT UNIFIED SCHOOL SHALL:

1. Meet with **CHS** to develop a referral and follow-up process for students with identified needs for counseling.
2. Inform students and staff of the counseling referral services.
3. Provide in-kind confidential facility space for counseling activities.
4. Provide use of a confidential telephone for counseling activities.

CENTER FOR HUMAN SERVICES SHALL:

1. Schedule students/ families who come with a referral form from **PSD** for an initial assessment as openings in case loads permit.
2. Provide Medi-Cal and/or Healthy Families billable counseling services in the form of individual, family or group as needed and available.
3. Provide their own malpractice insurance.

MUTUAL RESPONSIBILITIES - PATTERSON JOINT UNIFIED SCHOOL DISTRICT AND CENTER FOR HUMAN SERVICES:

1. **CHS** and **PSD** are responsible for their own materials and supplies.
2. Either party may terminate this Agreement, with or without cause, by giving thirty (30) days written notice to the other party.
3. Each party shall hold harmless and defend, save and keep the other and their elected officials, officers, employees, agents, and volunteers free from any and all liability for damages including, but not limited to monetary loss, judgments, fees, costs, and expenses, incurred by reason of claims, suits or decrees that may arise from any injury to a person or person or damages to property occurring during the performance of the work of or service determined by this Agreement.


TERMS


