

**Memorandum Of Understanding  
LICENSE TO USE THE LISA PROJECT in 10  
Patterson High School**

The Lisa Project in 10 is jointly copyrighted and owned by The San Joaquin County Child Abuse Prevention Council and Gene Hardin. The intent of this agreement is to outline what the Local Host (referred to as LH) can expect from The Lisa Project (referred as TLP), as well as the tasks and responsibilities of the LH to ensure a successful exhibit.

For the use fee of \$ 1,500 (per day or showing) 2 days in Patterson High School for a total of \$3,000- The Lisa Project will:

1. Transport to and erect The Exhibit at location secured by the LH. The lease of the exhibit is for a period of **2 days August 27 & 28, 2019 with a setup day on August 26, 2019.** This time frame allows for set up and on-site training for the LH staff and volunteers.
2. TLP is a self-contained, multi-sensory exhibit that includes all visual, auditory, and exhibit items. This includes:
  - a. All exhibit props
  - b. (35) audio devices (iPods) and related chargers.
  - c. TLP will supply Resource cards and wristbands for each visitor
3. TLP will provide on-site training for all LH staff and volunteers for the staffing of The Lisa Project. Total Volunteers needed each day of operation: 3 (Students). No volunteers are needed for setup or tear down of exhibit.
4. Promotional Materials: The following items will be provided by TLP for purposes of promotion and advertising:
  - a. 1,000 Resource cards (displaying phone numbers of partnering agencies)
  - b. 1,000 bracelets (imprinted with "The Lisa Project – Some secrets should be told")
  - c. **Artwork** for posters, emails and e-vites on as requested basis

*Where appropriate, local sponsors of the exhibit can be included on selected promotional items.*

*PLEASE NOTE: All printed materials are provided in English. The audio for the exhibit is provided in both English and Spanish*

All printing and reproductions including The Lisa Project information, logos or artwork, pictures, and related promotional items are copyrighted and ***may not be used without permission***. This includes but is not limited to e-mail invitations (e-vites) to events as well as artwork for inter-office memos and publications such as newsletters, flyers, websites, etc. To ensure the integrity and quality of the project, all reproduction will be coordinated through The Lisa Project.

The LH will:

1. Secure a location. This should be a minimum of 500 square feet, subject to approval by TLP, and ideally be located in a high-traffic area with ample parking close by. A copy of the written permission from the property owner to use said location must be provided to TLP within two months of the exhibit date – This does not apply to Schools or Universities
2. The LH shall make no alterations to TLP during the term of this agreement without the express knowledge and written consent of TLP.

**Terms and Conditions:**

The balance is due and payable prior to the first showing or first day in the high school.

***Balance due date: August 25<sup>th</sup>, 2019***

If, due to unforeseen circumstances, TLP is not able to honor the exhibit dates, Notice of Inability to Perform will be provided to the LH in writing. In this case, TLP will refund all monies received to the LH.

If, due to unforeseen circumstances, the LH is not able to honor the exhibit dates, Notice of Cancellation shall be provided to TLP in writing. In this case, the LH will pay to TLP expenses incurred to up the date of cancellation.

### Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

- Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)

- Form 1099-A (acquisition or abandonment of secured property)
