LICENSE AGREEMENT
EXTENSION AGREEMENT

This License Agreement Extension ("Extension Agreement") is entered into this July 1, 2019, by and between the San Joaquin County Office of Education, a county office of education of the state of California, (hereinafter "Provider") and the Patterson Joint Unified School District (hereinafter "Customer"), (collectively hereinafter "Parties")

INTRODUCTION

WHEREAS, the Provider is the operator and owner of a web-based suite of tools, known as the Student Success Team System Management System (hereinafter "BEYOND SST"), for use by schools, school districts and county offices of education in formulating, updating, tracking, storing and reporting on Pupil Records, including, but not limited to, Student Success Team and 504 forms;

WHEREAS, on **March 15, 2016** Provider and Customer entered into that certain document entitled Student Success Team Management System License Agreement ("Agreement") for Customer's use of BEYOND SST;

WHEREAS, the initial term of Agreement expires on **June 30, 2019**;

WHEREAS, pursuant to Section 4.1 of the Agreement, the Parties desire through this Extension Agreement to extend the term of the Agreement to allow for Customer's continued use of BEYOND SST;

NOW, THEREFORE, Provider and Customer agree that the terms and provisions of the Agreement are hereby amended and supplemented as set forth herein below:

1. The Agreement shall be extended from **June 30, 2019** through **June 30, 2022** ("Additional Term"). In consideration for the license to obtain access to and use BEYOND SST for the Additional Term, Customer agrees to pay Provider the License Fees as specified in Appendix "A" of the Agreement and calculated based on the most recent CBEDS enrollment count reported to the state of California for the Customer and any related entities listed in Appendix "B" of the Agreement, as of the current fiscal year.

Customer shall be invoiced for the Additional Term for the period of **July 1, 2019 – June 30, 2020** in the amount of four thousand dollars (\$4,000). Customer shall remit payment to Provider within thirty (30) calendar days of Customer's receipt of the invoice.

Customer shall be invoiced for the Additional Term for the period of **July 1, 2020 – June 30, 2021** in the amount of four thousand dollars (\$4,000). Customer shall remit payment to Provider within thirty (30) calendar days of Customer's receipt of the invoice.

Customer shall be invoiced for the Additional Term for the period of **July 1, 2021 – June 30, 2022** in the amount of four thousand dollars (\$4,000). Customer shall remit payment to Provider within thirty (30) calendar days of Customer's receipt of the invoice.

Notwithstanding the modifications or changes detailed above, the remainder of the Agreement remains unmodified and in full force and effect. This Extension Agreement, taken together with the Agreement, represents the new Agreement.
