Joe's Landscaping and Concrete, will not be held responsible for damages or encroachments because of errors in providing these items. *Title to materials shall not pass to the purchaser until consideration has been paid in full It is agreed that all material shall remain the property of Joe's Landscaping and Concrete regardless of the manner in which it is affixed. *All work is to be done in a workmanlike, timely manner according to the standard practices of the trade. *This proposal and its terms and conditions are to become a part of any other contract.
